


Minutes of the meeting held on 22-07-2014 at Trichy


The following decisions were taken unanimously after the discussion over the agenda. It is resolved to

- I. a) Form a co-ordination committee of AIGETOA & AIBSNLEA, TN Circle as per the guidelines given by the respective CHQs conveyed through joint declaration.  
b) The circle co-ordination committee will consist of (CCC) 12 (Twelve) members, 6 (Six) members from each association.  
c) The names of the members for the circle co-ordination committee will be given within two days and the final list will be released on 25-07-2014
- II. a) This meeting also takes decision to give direction to all the respective SSA branches to form co-ordination committee in the SSA level before 15-08-2014 and intimate the same to the circle co-ordination committee  
b) This committee also consists of 12 members, 6 members from each association
- III. Joint Declaration on the basis of the understanding reached between two CHQs through MOU will be drafted separately and will be finalized in the First CCC meeting to be held on 02-08-2014 at 15:00 hrs at Trichy and will be released.
- IV. In respect of election campaign work, the modalities/program will be discussed in the ensuring CCC meeting.
- V. It is proposed and appealed to the SSA branches of both the association to take efforts to meet the Administration to resolve the common issues jointly as decided by the both CHQs.
- VI. The Circle /District Secretary of AIBSNLEA will be the Convener and Circle/District Secretary of AIGETOA will be the Chairman at all levels.
