Sub: Calling for suggestions in respect of posting of Executives  
in outdoor Sub Divisions in TamilNadu area.

Instances have come to the notice of this office regarding the pending transfer requests specially, executives working in outdoor sub divisions for early consideration. It is a known fact that the infrastructure developments like Road widening, other utility agencies, private Telecom Operators are being executed in large scale, thereby causing frequent damages to the OFC Cables of STR. Such damages call for immediate attention irrespective of time of occurrence and executives working in the outdoor sub divisions are subjected to continuous strain and pressure for attending to such faults in time.

It is also seen that the executives posted in outdoor sub divisions , approach the management for change of posting due to absence of any transfer policy in respect of such outdoor posts. It is also observed that no specific guidelines are available in BSNL transfer policy for dealing such cases other than the guidelines pertaining to rotational transfer.

The maintenance of outdoor network is the most important activity and to be maintained with utmost care and diligence. In order to address the issue of posting of executives in outdoor sub divisions of Tamilnadu area, on long term basis, it is proposed to evolve a local policy for posting in the outdoor sub divisions. Hence, you are requested to send your suggestions in this regard on or before 18<sup>th</sup> June 2014 so as to work out a local policy of posting executives in outdoor Divisions / Sub Divisions..
